

SEVENTH SUPPLEMENTAL INDENTURE, dated as of October 1, 1967, between **THE GAS SERVICE COMPANY**, a corporation organized and existing under the laws of the State of Delaware ("Company"), party of the first part, and **THE CHASE MANHATTAN BANK (NATIONAL ASSOCIATION)**, a national banking association existing under the laws of the United States of America ("Principal Trustee"), and **COMMERCE TRUST COMPANY**, a corporation organized and existing under the laws of the State of Missouri and having its principal office and place of business in Kansas City, Missouri (hereinafter together with the Principal Trustee called the "Trustees"), as Trustees, parties of the second part.

WHEREAS the Company heretofore executed and delivered an Indenture of Mortgage and Deed of Trust, dated as of September 1, 1949 ("Original Indenture"), to The Chase National Bank of the City of New York and Commerce Trust Company, as Trustees, to secure its First Mortgage Bonds, issuable in series, and created thereunder an initial series of bonds designated First Mortgage Bonds, 2 7/8 % Series due 1969; and

WHEREAS the Company heretofore executed and delivered a First Supplemental Indenture, dated as of June 1, 1951, to The Chase National Bank of the City of New York and Commerce Trust Company, as Trustees, for the purpose of creating thereunder an additional series of bonds, and of conveying additional property of the Company; and

WHEREAS the Company heretofore executed and delivered a Second Supplemental Indenture, dated as of July 1, 1954, to The Chase National Bank of the City of New York and Commerce Trust Company, as Trustees, for the purpose of creating thereunder an additional series of bonds; and

WHEREAS, in 1955, The Chase National Bank of the City of New York merged into President and Directors of the Manhattan Company under the name of The Chase Manhattan Bank and The Chase Manhattan Bank became a successor Trustee under the Indenture; and

WHEREAS the Company heretofore executed and delivered to The Chase Manhattan Bank and Commerce Trust Company, as Trustees,
