and being recorded in Volume 123 of Mortgages on Page 30 in the office of the Register of Deeds of Douglas County, Kansas.

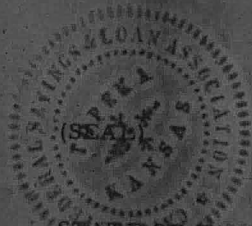
