

MORTGAGE 13289 (NO. 32C) BOOK 150

Witnesseth, That said parties of the first part, in consideration of the sum of
Fifteen thousand eight hundred and no/100 DOLLARS
the receipt of which is hereby acknowledged, do by these presents, grant, bargain, sell and convey unto
said part y of the second part, its heirs and assigns, all the following REAL ESTATE situated in
the County of Douglas and State of Kansas, to-wit:

Lot Fifteen (15), in Block Fourteen (14), in Indian Hills No. 2
and Replat of Block Four (4) Indian Hills, an Addition to the City
of Lawrence, as shown by the recorded plat thereof, in Douglas
County, Kansas.

To Have and To Hold the Same, Together with all and singular, the tenements, hereditaments and appur-
tenances thereunto belonging, or in anywise appertaining, forever:

Provided Always, And these presents are upon this express condition, that whereas said
parties of the first part have this day executed and delivered
one certain promissory note in writing to said part y of the second part, of which the following

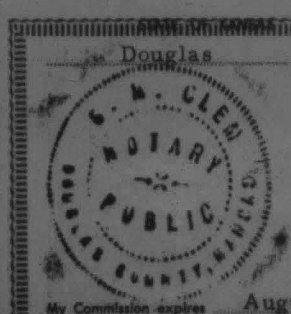
Now, if said part ies of the first part shall pay or cause to be paid to said part y of the second part its

may be assessed and levied against said premises or any part thereof, are not paid when the same are by law
made due and payable; then the whole of said sum and sums and interest thereon, shall, and by these presents,
become due and payable, and said part y of the second part shall be entitled to the possession of said
premises.
