In monthly installments of \$106.46 each, including both principal and interest. First payment of \$ 106.46

due on or before the <u>lat</u> day of <u>August</u>, 19.68, and a like sum on or before the <u>lat</u> day of each month thereafter until total amount of indebtedness to the Association has been paid in full.

Said note further provides: Upon transfer of title of the real estate, mortgaged to secure this note, the entire balance aining due hereunder may at the option of the mortgages, be declared due and payable at once.

In the failure of second party to assert any of its right hereunder at any time shall not be construed as a waiver of its right to assert the same sta later time, and to insuit upon and enforce strict compliance with all the terms and provisions in asid note and in this mortgage contained.
