FIRST SUPPLEMENTAL INDENTURE, dated as of the twenty-third day of September, 1968, made by and between MAPCO INC. (formerly named Mid-America Pipeline Company), a corporation duly organized and existing under the laws of the State of Delaware and having its principal office at 1437 South Boulder Avenue, Tulsa, Oklahoma 74119 (hereinafter called the "Company"), party of the first part, and BANKERS TRUST COMPANY, a corporation duly organized and existing under the laws of the State of New York and having its principal corporate trust office at 16 Wall Street, New York, New York 10015 (hereinafter called the "Trustee"), and Howard W. HADLEY, residing at 6348 Washington Avenue, University City, Missouri 63130 (hereinafter called the "Individual Trustee"), the Trustee and the Individual Trustee being hereinafter called the "Trustees"), as Trustees, parties of the second part, the business address of the Individual Trustee being c/o St. Louis Union Trust Company, 510 Locust Street, St. Louis, Missouri 63104.

WHEREAS, the Company has heretofore duly executed and delivered to the Trustees its Mortgage and Deed of Trust, dated May 1, 1960 (hereinafter called the "Original Indenture"), whereby all the properties of the Company whether owned at the time of the execution thereof or thereafter acquired, other than excepted property as therein defined and set forth, were granted, assigned, conveyed, transferred, mortgaged, and pledged to the Trustees in trust upon the terms and conditions set forth therein to secure bonds of the Company issued and to be issued in accordance with the terms of the Original Indenture as it may from time to time be supplemented, modified or amended (the Original Indenture as heretofore supplemented and as supplemented and amended by this First Supplemental Indenture being hereinafter referred to as the "Indenture"); and

WHEREAS, the Original Indenture has heretofore been supplemented by eight duly executed Supplemental Mortgages of Property, each dated June 1, 1960, ten duly executed Supplemental Mortgages of Property, each dated July 1, 1960, ten duly executed Supplemental Mortgages of Property, each dated August 1, 1960, ten duly executed Supplemental Mortgages of Property, each dated September 1, 1960, nine duly executed Supplemental Mortgages of Property, each dated December 1, 1960, ten duly executed Supplemental Mortgages of Property, each
