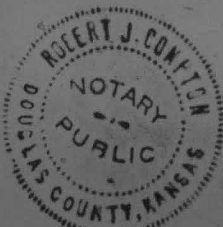

WITNESSETH, That the Mortgagee, for and in consideration of the sum of Twelve Thousand One Hundred
and No/100 ----- Dollars (\$ 12,100.00),
the receipt of which is hereby acknowledged, does by these presents mortgage and warrant unto the Mortgagee, its
successors and assigns, forever, the following-described real estate, situated in the County of Douglas
State of Kansas, to wit:

Commencing at a point 65 feet South of a point on the South side of Adams Street
in the City of Lawrence, where the same is intersected by the East line of Pennsylvania
Street, as now laid out between Adams and Morris Streets, (now known as Fourteenth
and Fifteenth Streets); thence East parallel with the South line of Adams Street 117
feet; thence South parallel with the East line of Pennsylvania Street 65 feet; thence
