1. The East one-half of Lot 3, Block 5, First Addition to the Town of Bucyrus, Miami County, Kansas, such part of Lot 3 described as follows: Beginning at the Southeast corner of said Lot; thence West 70 feet; thence North 50 feet; thence South 50 feet to the point of beginning, containing in all 3,500 square feet, more or less;

12. All that certain tract of land in the Southeast Quarter of the Southeast Quarter of Section 3, Township 19 South, Range 9 East of the Sixth Principal Meridian in Chase County, Kansas, bounded as follows:

Beginning at a point on the south line of said Section 3 distant 330 feet west of the Southeast corner thereof; running thence north 50 feet; thence west 50 feet; thence south 50 feet; and thence east 50 feet to the place of beginning;
13. Lots 5, 6, 7 and the South 159 feet of Lot 31, Block 4 of Golden Gardens, a subdivision of the Northwest Quarter of Section 31, Township 23 South, Range 6 West of the Sixth Principal Meridian in Reno County, Kansas;
