his wife; Robert B. Oyler and Corinne Oyler, his wife  
 of Shawnee County, in the State of Kansas, of the first part, and CAPITOL FEDERAL SAVINGS AND LOAN ASSO-  
CIATION of Topeka, Kansas, of the second part;  
 WITNESSETH: That said first parties, in consideration of the loan of the sum of Thirty Thousand Seven Hundred  
Fifty and No/100- ----- DOLLARS  
 made to them by second party, the receipt of which is hereby acknowledged, do by these presents mortgage and warrant unto  
 said second party, its successors and assigns, all of the following-described real estate situated in the County of Douglas  
 and State of Kansas, to-wit:

PROVIDED ALWAYS, And this instrument is executed and delivered to secure the payment of the sum of Thirty  
Thousand Seven Hundred Fifty and No/100- ----- DOLLARS  
 with interest thereon, advanced by said Capitol Federal Savings and Loan Association, and such charges as may become due  
 to said second party under the terms and conditions of the note secured hereby, which note is by this reference made a
