

20645 MODIFICATION AGREEMENT

THIS AGREEMENT made and entered into this 23rd day of January, 1970, by and between H. Lee Zimmerman and Kathleen L. Zimmerman, his wife hereinafter called the Mortgagor(s), and The Fidelity Investment Company, a corporation organized and existing under the laws of the State of Kansas, hereinafter called the Mortgagee.

WHEREAS the Mortgagor has formerly mortgaged to the Mortgagee the following described property:

Apartment 8-A of "The Fountains", which is a portion of Lot 28, Holiday Hills No. 7, an addition to Lawrence, Douglas County, Kansas,

by Mortgage dated December 1, 1969, and recorded in Book 155, Page 360, in the office of Register of Deeds of Douglas County, Kansas, on December 10, 1969.

NOW THEREFORE in consideration of the mortgage loan heretofore made, the Mortgage is amended by adding the following paragraph to said Mortgage:

"Should the premises or any part thereof be taken or damaged by reason of any public improvement or condemnation proceeding, or under right of eminent domain, or any transfer by private sale in lieu thereof, the Mortgagee shall be entitled to all compensation, awards, and any other payment or relief therefor, and shall be entitled at its option to commence, appear in, and prosecute in its own or Mortgagor's name any action, or proceedings, or to make any compromise or settlement in connection with such taking or damage. All such compensation, awards, damages, rights of action, and proceeds are hereby assigned to the Mortgagee, who may after deducting therefrom all its expenses, including attorney's fees, release any moneys so received by it or apply the same on any indebtedness secured hereby. The Mortgagor agrees to execute such further assignments of any compensation, awards, damages, and rights of action and proceeds as the Mortgagee may require."

It is so understood between parties hereto that all the conditions and agreements in the above described mortgage shall remain in full force and effect.
