## 20647 MODIFICATION AGREEMENT BOOK 156

THIS AGREEMENT made and entered into this 23rd day of January, 1970, by and between Carl Hird, Jr. and Irene M. Hird, his wife

hereinafter called the Mortgagor(s), and The Fidelity Investment Company, a corporation organized and existing under the laws of the State of Kansas, hereinafter called the Mortgagee.

All such compensation, awards, damages, rights of action, and proceeds are hereby assigned to the Mortgagee, who may after deducting therefrom all its expenses, including atto:mey's fees, release any moneys so received by it or apply the same on any indebtedness secured hereby. The Mortgagor agrees to execute such further assignments of any compensation, awards, damages, and rights of action and proceeds as the Mortgagee may require."

It is so understood between parties hereto that all the conditions and agreements in the above described mortgage shall remain in full force and effect.
