All such compensation, awards, damages, rights of action, and proceeds are hereby assigned to the Mortgagee, who may after deducting therefrom all its expenses, including attorney's fees, release any moneys so received by it or apply the same on any indebtedness secured hereby. The Mortgagor agrees to evecute such further assignments of any compensation, awards, damages, and rights of action and proceeds as the Mortgagee may require." rights of action and proceeds as the Mortgagee may require."
