- (1) Lot 15A in Addition 3, in that part of the City of Lawrence known as North Lawrence, in Douglas County, Kansas.
- (2) Lot Thirty-Five (35) in Northeast Central Subdivision in the City of Lawrence, Kansas, known as North Lawrence (located 778 Locust Street)
- (3) Beginning at the Southwest corner of Lot 35 in Northeast Central Sub-division in the City of Lawrence, Kansas, known as North Lawrence, thence South 56 feet, thence East 50 feet, thence North 56 feet, to the Southeast corner of said Lot 35, thence West 50 feet to the place of beginning in that part of the City of Lawrence, Kansas, known as North Lawrence (located 778 Locust Street)
- (4) Lots 95 and 97 on Grove Street in the City of Baldwin City, Kansas (located North side of Grove Street about 100 feet East of 11th Street)
- (5) Lots 99 and 101 on Grove Street in the City of Baldwin City, Kansas (located Northeast corner of Grove and 11th Street).
- (6) Lot Thirty-Three in Frazier's Subdivision of Lots 6 to 15 inclusive in Addition No. 4 in that part of the City of Lawrence, Kansas, known as North Lawrence (located approximately 150 feet West of North 4th Street on North side of Funston).
- (7) Lot Seventeen (17), Block One (1), in Belmont, an addition to the City of Lawrence, Kansas (located approximately 350 feet South of 13th Street on the West side of Brook Street).
- (8) Lot Five (5) Block Nine (9) Homewood Gardens, an addition to the City of Lawrence, Kansas (located between LaSallee and Lynn Streets on the West side of Bullene Avenue).
- (9) Lot Seventy-One (71), less East 60 feet thereof, in Block Twelve (12) in the City of Lawrence, Kansas, known as West Lawrence (located on North side of 3rd Street and between Alabama and Maine Streets).
- (10) Lot Twenty-five (25) in Block One (1) in Belmont Addition, an Addition to the City of Lawrence, Kansas, located on the West side of Brook Street in the 1300 Block.
- (11) Two (2) acres west of road and North of Creek of that portion of Northwest Quarter (NW<sup>1</sup>/<sub>4</sub>) of Southeast Quarter (SE<sup>1</sup>/<sub>4</sub>) lying North of center of Rock Creek, also described as: Beginning at a point in public road 230 feet East and 200 feet South of Northwest corner of Southeast Quarter (SE<sup>1</sup>/<sub>4</sub>) of Section Seven (7), Township Fourteen (14), Range Eighteen (18), thence South to center of Ravine, thence in southerly direction down center said ravine to center of Rock Creek, thence following meanderings of said Rock Creek, first in Easterly direction, thence in a Northerly direction to a point where the center of said Rock Creek intersects center of public road, thence in a northwesterly direction along center of said public road to the place of beginning, containing 2 acres, more or less.
