Any deficiency in the amount of such aggregate monthly payment shall, unless made good by the Mortgagor prior to the due date of the next such payment, constitute an event of default under this mortgage. The covenants herein contained shall bind, and the benefity and advantages shall inure to, the respective heirs, executors, administrators, successors and assigns of the parties hereto.
