WITNESSETH: That said first parties, in consideration of the loan of the sum of Twelve Thousand Five Hundred Fifty and No/100 DOLLARS made to them by second party, the receipt of which is hereby acknowledged, do by these presents mortgage and warrant unto said second party, its successors and assigns, all of the following-described real estate situated in the County of Douglas and State of Kansas, to-wit:
