IT IS the intention and agreement of the parties hereto that this mortgage shall also secure in addition to the mortgage, and any and all indebtedness, any future advances made to said mortgagor, or any of them or their successors in title, by the mortgagee, and any and all indebtedness in addition to the amount above stated which the said mortgagor, or any of them in full force and effect between the parties hereto and their heirs, personal representatives, successors and assigns, until present indebtedness for any cause, the total debt on any such additional loans shall at the same time and for the same specified causes be considered matured and draw ten per cent interest and be collectible out of the proceeds of sale through that if any improvement.
