Location: 304 East Main Street
Brownsburg, Indiana

Description: A parcel of land consisting of part of the Northeast Quarter of the Southwest Quarter of Section 11, Township 16 North, Range 1 East, of the Second Principal Meridian in Hendricks County, Indiana. Said part being more particularly described as follows: Commencing at the Northeast corner of said Quarter Quarter Section; thence South 00 degrees 00 minutes 00 seconds East on and along the East line of said Quarter Quarter Section 708.150 feet to a point on the center line of U.S. 136 (East Main Street, Brownsburg, Indiana) as now located and established; thence North 68 degrees 47 minutes 18 seconds West on and along said center line 307.700 feet to the Beginning Point of this description; thence continuing North 68 degrees 47 minutes 18 seconds West on and along said center line 132.737 feet; thence North 00 degrees 00 minutes 00 seconds West 180.180 feet; thence South 68 degrees 47 minutes 18 seconds East 132.737 feet; thence South 00 degrees 00 minutes 00 seconds East 180.180 feet to the beginning point of this description.
