

This Indenture made this fifth day of April in the year of  
 Lord one thousand eight hundred and eighty seven, between Thomas  
 McLaughlin and Catharine McLaughlin, his wife of Douglas County  
 Kansas, of the first part, and William T. Sinclair of Lawrence Kan-  
 sas of the second part witnesseth, that the said parties of the first  
 part, for and in consideration of the sum of Six hundred and fifty dollars  
 to them in hand paid by the said party of the second part, the receipt  
 whereof is hereby confessed and acknowledged, have granted bargained  
 sold and conveyed, and by these presents do grant bargain sell and  
 convey unto the said party of the second part and to his heirs and assigns  
 forever all the following described piece and parcel of land lying and  
 situate in the township of Eudora County of Douglas and State of  
 Kansas, to wit, The north east quarter of Section No. twenty-four  
 (24) in township No. thirteen (13) south of range No. twenty (20.)  
 east of 6<sup>th</sup> Principal Meridian. Containing 160 acres more or less.

To have and to hold the same with all and singular the hereditaments  
 and appurtenances thereunto belonging, unto the party of the second  
 part and to his heirs and assigns forever. And the said parties of  
 the first part do hereby covenant and agree that at the delivering hereof  
 they are the lawful owners of the premises above granted, and seized of  
 a good and indefeasible estate of inheritance therein free and clear of all  
 incumbrances, and that they will warrant and defend the same in the quiet  
 and peaceable possession of the said party of the second part his heirs and  
 assigns forever, against all persons lawfully claiming the same.

Provided always and these presents are upon this express condition, that  
 Whereas the said Thomas McLaughlin and Catharine McLaughlin are  
 fully indebted unto the said Wm T. Sinclair in the principal sum of  
 Six hundred and fifty dollars lawful money of the United States of Amer-  
 ica, being for a loan thereof on the day and date hereof, made by the said  
 Wm T. Sinclair to the said Thomas McLaughlin and Catharine McLaughlin  
 and secured to be paid by the certain promissory note of the said Thomas Mc-  
 Laughlin and Catharine McLaughlin, bearing even date herewith pay-  
 able to the order of the said Wm T. Sinclair in five (5) years from the date  
 hereof at the office of the said Wm T. Sinclair in the city of Lawrence and  
 State of Kansas, with interest after maturity at the rate of twelve per cent  
 per annum until the said principal sum is fully paid. The interest on  
 said note from date is to be paid semi-annually on the fifth day of  
 April and of October in each and every year and is specified by  
 interest notes or coupons of even date herewith attached to the said note  
 and payable at the said office of Wm T. Sinclair in the city of Lawrence  
 Kansas, and in and by said promissory note it is agreed that if default  
 be made in the payment of any interest coupon at maturity, then the
