-----Dollars (\$11,900.00 -----) and all its right, title, and interest in and to the premises situated in the County of

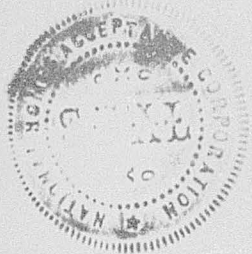
Douglas, State of Kansas, and described in said mortgage as follows, to-wit:
