Witnesseth, That the parties of the first part, in consideration of the sum of Eighty Dollars to them in hand paid, the receipt whereof is hereby acknowledged, have sold, and by these presents do grant, bargain, sell and convey to the said party of the second part his heirs and assigns forever, the following tract or parcel of land situated in the County of Douglas and State of Kansas, described as follows to wit: Beginning at a point 11<sup>42</sup> chains South of the North line & 8<sup>00</sup> chains West of the East line of the North West Quarter of section thirty six Township two North of Range Nineteen (19) thence running West 14<sup>23</sup> chains thence South 7<sup>52</sup> chains thence East 5<sup>2</sup> chains thence South 2<sup>43</sup> chains thence East 11<sup>04</sup> chains thence North 10<sup>20</sup> chains to the beginning containing 14 acres being the homestead of the first parties with the appurtenances and all the estate, title and interests of the said parties of the first part therein above granted, and seized of a good and indefeasible estate of inheritance therein, that they have good right to sell and convey said premises, subject however to a prior mortgage for \$1600.00 of this date, made to Edward Russell.
