Whereas on the first day of February A. D. 1889 the undersigned Guardian of  
the Estate of Jennie Randall, Carrie Randall, and Paul Randall minor heirs  
of Reuben Randall deceased presented to the Probate Court of Douglas County  
Kansas, her petition praying for an order of said Court authorizing her as  
such Guardian to raise money necessary for the support Maintenance and  
Education of said minors by mortgaging real estate belonging to said minors  
And Whereas the said Probate Court of Douglas County Kansas, acting  
on said petition did by its order of date March 1<sup>st</sup> 1889 authorize and direct
