

the discharge of his duties: And whereas said subsequently on the Eleventh day of August A.D. 1873 the said Receiver did make a report to said Court of all his doings in and about said appointment and of the affairs of said Corporation: And whereas the said District Court did then and there order said Receiver to cancel satisfy and discharge certain Mortgages scheduled in the report of said Receiver: and as to certain other notes, Mortgages and obligations not so scheduled and ordered to be cancelled the said Court did order and decree that the same be delivered over to Edward Rafe and C. Nahrung, with all the rights of The said The Home Insurance Company therein so far as said property was concerned: And whereas said Court did then and there adjudge, order and decree the dissolution of said The Home Insurance Company as a Corporation under the laws of the State of Kansas and did then and there discharge said Receiver from his said trust: And whereas the original pleadings and papers in said action together with the report and schedule made by said Receiver have become much laid lost or destroyed, and cannot be found on the files of said Court: And whereas the Mortgages hereinafter mentioned and described have been long since fully discharged as existing obligations, and should be of right discharged of record. Now therefore Edward Rafe and being the same Edward Rafe named in the decree of said Court as a residuary assignee of the assets of said Corporation, do hereby acknowledge that the following described mortgages given unto said The Home Insurance Company of Peoria Illinois: A Mortgage given by Bruno and C. Bruno his wife, dated April 23, 1873 and recorded April 29, 1873 in Book L, page 45 Douglas County, Kansas records of Mortgages, and given on the North East Quarter of Section No Ten (10) in Township No Twelve (12) of Range No. Nineteen (19). The undivided one half of the South half of the North West quarter Section No 11 Town 12 Range 19 and the South West fractional quarter of Section No 3 Town 12 Range 19 - less 14 acres off West end thereof, All in Douglas County, Kansas. A Mortgage given by August Brommelick and Francisca Brommelick his wife of date July 27, 1871 and recorded Aug. 23, 1871 in Book I, at page 175 of Douglas County, Kansas record of Mortgages, and being given on Lot No. twenty one (21) on Chase Island Street in the City of Lawrence Douglas County, Kansas. A Mortgage given by John Mason of date March 25, 1873 and recorded April 29, 1873 in Book I at page 55 of Douglas County, Kansas record of Mortgages, and being given on the South East quarter of Section No Four (4) in Township No Twelve (12) of Range No Eighteen (18) in Douglas County, Kansas - have been fully satisfied, and do hereby authorize the Register of Deeds of Douglas County, Kansas to discharge said Mortgages of record.
