This Indenture Made this 29th day of June in the year of our Lord, one thousand eight
hundred and eighty nine between George W. Kirchhoff and Minnie Kirchhoff his wife of the
City of Lawrence in the County of Douglas and State of Kansas of the first part, and The
Home Building and Loan Association of the City of Lawrence, in said County of Douglas
of the second part, Witnesseth that the parties of the first part, in consideration of the
sum of Five Hundred Dollars, to them duly paid in cash, and by these presents do grant
and convey to the said party of the second part and its assigns all that tract or par-
cel of land situated in said Douglas County, and State of Kansas and described as follows
to-wit: Lots Nos. Eight (8) and Nine (9) in Sogard Place, an Addition to the City of Lawrence
with the appurtenances and all the estate, title and interest of the parties of the first
part therein.

This Grant is intended as a Mortgage to secure the payment and the full perfor-
mance of all the obligations and conditions of a certain Bond this day executed
by the said George W. Kirchhoff to the said Home Building and Loan Association for the
payment of \$500. as therein provided; and upon the full and prompt performance
of said conditions of said bond by the party signing the same, this conveyance
shall be void. But if default be made in the performance of any of the conditions
of said bond, or in the making of any payments therein provided when the same
shall be due; or if the taxes and assessments of every nature which are assessed
or levied against said premises are not paid at the time when the same are by law
made due and payable, then, upon the happening of any of said failures, the whole
of the said sum of \$500. together with such fines and penalties as shall accrue under
the By-Laws of said Association shall immediately become due and payable,
and it shall be lawful for the said party of the second part, or its assigns at any
time thereafter, to sell the premises here by granted, or any part thereof, in the man-
ner prescribed by law, and out of all the money arising from such sale, to retain
