This Indenture, Made this 31st day of December in the year of our Lord one thousand eight hundred and eighty three between Alphonso E. Hitchcock and Rose D. Hitchcock his wife of Douglas in the County of Douglas and State of Kansas of the first part, and William E. Sinclair, of Lawrence Kansas of the second part,

Witnesseth, That the said parties of the first part in consideration of the sum of Three hundred DOLLARS, to them duly paid, the receipt of which is hereby acknowledged, have sold and by these presents do—grant, bargain, sell and mortgage to the said party of the second part his heirs and assigns forever, all that tract or parcel of land situated in the County of Douglas and State of Kansas, described as follows, to-wit: The North one third part of the North West quarter of Section No. Twenty four (24) in Township No. Thirteen (13) North, of Range No. Nineteen (19) East of the 6th P.M. more particularly described as beginning at the N. W. corner of said Section and running South on the West line of 33 and 3 rods, thence East on a line parallel with the North line of sd. Sec. 160 rods to the East line of sd. Sec. then on North on the East line of 33 and 3 rods to the N. E. corner of sd. Sec. then on West on North line of sd. Sec. 160 rods to place of beginning with all the appurtenances, and all the estate, title and interest of the said parties of the first part therein. And the said parties of the first part do—hereby covenant and agree that at the delivery hereof they are the lawful owners of the premises above granted, and seized of a good and indefeasible estate of inheritance therein free and clear of all incumbrances and that they will warrant and defend the same in the quiet and peaceable possession of the said party of the second part his heirs and assigns forever against all persons lawfully claiming the same.

This grant is intended as a Mortgage to secure the payment of the sum of Three hundred Dollars

according to the terms of one certain mortgage note this day executed and delivered by the said parties of the first part to the said party of the second part: due in three years from date, with interest after maturity or default, at the rate of ten per cent per annum, the interest from date to maturity or default, being evidenced by coupons attached to said note

and this conveyance shall be void if such payments be made as herein specified. But if default be made in such payment, or any part thereof, or interest thereon, or the taxes, or if the insurance is not kept up thereon, then this conveyance shall become absolute, and the whole amount shall become due and payable, and it shall be lawful for the said party of the second part his executors, administrators and assigns, at any time thereafter, to sell the premises hereby granted, or any part thereof, in the manner prescribed by law, appraisement hereby waived or not at the option of the party of the second part his executors, administrators or assigns; and out of all the moneys arising from such sales, to retain the amount then due for principal and interest, together with the costs and charges of making such sales, and the overplus, if any there be, shall be paid by the party making such sale on demand to the said parties of the first part, their heirs and assigns.
