

This Indenture, Made this 18th day of November in the year of Our Lord One
 Thousand Eight Hundred and Ninety between W. H. Wright and Kate
 Wright his wife of Mound City in the County of Linn and State of Kansas
 of the first part, and Eastern Kansas Banking Co. of the second part:
 Witnesseth, That the said parties of the first part, in consideration
 of the sum of Three Thousand and Six hundred and Seventy Seven ⁷⁰⁰⁰/₁₀₀ Dol-
 lars, to them duly paid, the receipt of which is hereby acknowledged,
 have sold and by these presents do Grant, Bargain, Sell and Mort-
 gage to the said party of the second part its successors and as-
 signs forever, all that tract or parcel of land situated in the County
 of Linn and State of Kansas, described as follows, to wit: Lots Four (4)
 in Block Twenty Three (23) and Lot four (4) and the East half of Lot five (5) Block
 Eleven (11) and Lot fourteen (14) and the East half of Lot Thirteen (13) in Block
 forty one (41) and Lot five (5) in Block fifteen (15) and Lots Six (6) Thirteen (13)
 Fourteen (14) and Fifteen (15) in Block Two (2) and Lot Twelve (12) in Block
 Two (2) and Lot One (1) in Block Eight (8) and Lots Two (2) and Three (3) in Block
 Eight (8) and Lot Fourteen (14) in Block fourteen (14) and Lots Two (2) and Three (3)
 in Block Twenty Three (23) and Lot Nine (9) in Block Twelve (12) and Twenty-two
