

This Indenture, Made this 19th day of November in the year of Our Lord One Thousand and Eight Hundred and Ninety between W. H. Wright and his wife Kate Wright of Mound City in the County of Linn and State of Kansas of the first part, and Wm. Ryly, O. W. Wilson and A. D. Wilson partners as Ryly Wilson & Co, parties of the second part.

Witnesseth, That the said part of the first part, in consideration of the sum of Four hundred and fifty three ¹⁵/₁₀₀ Dollars, to them duly paid, the receipt of which is hereby acknowledged, have sold and by these presents do Grant, Bargain, Sell and Mortgage to the said parties of the second part, their heirs and assigns forever, all that tract or parcel of land situated in the County of Linn and State of Kansas, described as follows, to-wit Lots Four (4) in Block Twenty three (23) and Lot four and East half of Lot five (5) in Block Eleven (11) and Lot fourteen (14) and the east half of Lot Thirteen (13) in Block forty one (41) and Lot five (5) in Block fifteen (15) and lots ~~one (1) four (4) and fifteen (15)~~ and lots six (6) Thirteen (13) fourteen (14) and fifteen (15) in Block Two (2) and Lot Twelve (12) in Block Two (2) and Lot One (1) in Block Eight (8) and lots two and three (2 & 3) in Block Eight (8) and Lot fourteen (14) in Block fourteen (14) and lots two (2) and three (3) in Block Twenty three (23) and Lot Nine (9) in Block Twelve (12) and Twenty Two feet and nine inches (22 ft 9 in) off of the east side of Lot Twelve (12) and Nine (9) inches off of the West side of Lot Thirteen (13) the full length of said lots. Also an undivided one third interest in a strip of land six feet wide running north and south across Lot Thirteen (13) and adjoining on the West side that part of Lot thirteen (13) heretofore deeded to O. P. Watson and to be used as a public hallway appurtenant to the Opera House all in Block fifteen (15) also an undivided one fifth interest in the barn situated on the north end of lots Twelve (12) & Thirteen (13) in said block (15) fifteen All in the City of Mound City as shown by the Original Town plat of said City.
