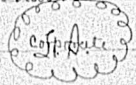


Whereas Ruee Syinger and John Syinger her husband of the County of Douglas, State of Kansas, executed and delivered to The Kansas Loan & Trust Company, as Trustee, a Deed of Trust bearing date April Second AD 1888 conveying to it in trust, for the purposes therein set forth, the following described premises, situate in the County of Douglas and State of Kansas, to wit: Beginning at the Southeast corner of the South west fractional quarter of Section No Seven (7) running thence North One hundred (100) rods thence West Fifty (50) rods thence South One hundred (100) rods, thence East Fifty (50) rods to the place of beginning, less the following, commencing One hundred (100) rods North of the Southeast corner of said Southwest fractional quarter of Section No Seven (7) running thence West Fifty (50) rods, thence South Eight (8) rods and Eight (8) feet and three (3) inches, thence East thirty three (33) rods to the Bank of Dry Branch, following said Bank North easterly to the east line of said quarter section and to beginning. Also commencing Fifty (50) rods East of the South west corner of said Southwest fractional quarter of Section No Seven (7) running thence east thirty two (32) rods and seven (7) feet, thence North Twelve (12) rods and Eleven (11) feet, thence West thirty two (32) rods and seven (7) feet, thence South Twelve (12) rods and Eleven (11) feet to beginning. Also beginning at the North east corner of the North west fractional quarter of Section No Eighteen (18) running thence West Eighty one $\frac{2}{3}$ rods, thence South One hundred (100) rods, thence West fifty (50) rods, thence South Sixty (60) rods, thence East One hundred and thirty one and $\frac{2}{3}$ (131 $\frac{2}{3}$) rods, thence North One hundred and Sixty (160) rods to place of beginning. All in Township No Thirteen (13) South, of Range No. Eighteen (18) East of the Sixth P.M. Containing One hundred thirty one (131) acres more or less, a record of which deed of Trust appears in volume 18 at page 501 in the records of the office of the Register of Deeds of the County last aforesaid. And, whereas, the conditions of said Trust Deed have been fulfilled, and said Deed has become fully satisfied, and the note of \$200 secured thereby has been paid in full.

Now therefore, The Kansas Loan & Trust Company, Trustee under said Deed, and E. M. Shelden holder and present owner of the promissory note secured thereby, by in consideration of the premises and of the sum of one dollar, to us in hand paid before the delivery hereof, do hereby release and forever quit claim to the said Ruee Syinger and John Syinger their heirs and assigns, all right, title, and interest in or to the premises aforesaid in us vested by virtue of said Trust Deed.
