

This Indenture, Made this first day of March in the year of our Lord one thousand eight hundred and ninety three, between George Neck and Anna Maria Neck, his wife of Douglas in the County of Douglas and State of Kansas of the first part, and Ed O'Caravan, of Jefferson County Kansas of the second part,

Witnesseth, That the said party of the first part in consideration of the sum of Eight Hundred DOLLARS, to them duly paid, the receipt of which is hereby acknowledged, have sold and by these presents do grant, bargain, sell and mortgage to the said party of the second part his heirs and assigns forever, all that tract or parcel of land situated in the County of Douglas and State of Kansas, described as follows, to-wit: All that portion of the east half of the South East quarter of Section No One (1), in Township No twelve (12) South of Range No Thirteen (13) East of the 6<sup>th</sup> P.M., lying North of the Union Pacific Railroad containing 77 acres, more or less.

with all the appurtenances, and all the estate, title and interest of the said party of the first part therem. And the said party of the first part do hereby covenant and agree that at the delivery hereof they are the lawful owners of the premises above granted, and seized of a good and indefeasible estate of inheritance therein free and clear of all incumbrances except a mortgage of \$1800 now on said land, in favor of Anna Bigelow

This grant is intended as a Mortgage to secure the payment of the sum of Eight Hundred Dollars

according to the terms of Two certain promissory notes this day executed and delivered by the said party of the first part to the said party of the second part each for the sum of \$400, one due August 1, 1893, and the other due August 1, 1894, with interest from date to maturity at the rate of eight per cent per annum, and interest after maturity at the rate of ten per cent per annum, until fully paid and this conveyance shall be void if such payments be made as herein specified. But if default be made in such payment, or any part thereof, or interest thereon, or the taxes, or if the insurance is not kept up thereon, then this conveyance shall become absolute, and the whole amount shall become due and payable, and it shall be lawful for the said party of the second part to sell the premises hereby granted, or any part thereof, in the manner prescribed by law, appraisement hereby waived or not at the option of the party of the second part the executors, administrators or assigns; and out of all the moneys arising from such sales, to retain the amount then due for principal and interest, together with the costs and charges of making such sales, and the overplus, if any there be, shall be paid by the party making such sale or demand to the said party of the first part, their heirs and assigns.
