This Indenture, Made this first day of October in the year of our Lord One
Thousand Eight Hundred and Ninety four, between E. S. T. Phillips and Augusta
A. Phillips, husband and wife of the City of Lawrence, County of Douglas
and State of Kansas, of the first part, and The Atlas Building and Loan
Association of Lawrence Kansas, of the second part,
Witnesseth, That the parties of the first part in consideration of the
sum of Seven Hundred Dollars (\$700.00) to them duly paid, have sold,
and by these presents do grant, bargain sell and convey unto the party
of the second part, its successors and assigns, all that tract and parcel
of land situated in the County of Douglas and State of Kansas, and de-
scribed as follows, to wit, Beginning twenty eight rods (78 R.) West of the
South East corner of the Northeast Quarter of the Northwest Quarter of the South
West Quarter of Section Twenty Nine (29) in Township Twelve (12) South, Range
Twenty (20), East of the Sixth Principal Meridian, in the centre of Elm Street,
produced East from North Lawrence; thence North eight (8) rods, thence East twenty
eight (78) rods, thence South eight (8) rods, thence West twenty eight (78) rods
to the place of beginning, together with all the tennants, hereditaments
and appurtenances thereto belonging or in anywise appertaining;
and said parties of the first part do hereby covenant and agree that at
the delivery hereof they are the lawful owners of the premises above
described, and seized of a good and indefeasible estate of inheritance
therein, free and clear of all incumbrances, and that they will war-
rant and defend the same in the quiet and peaceable possession of the
said party of the second part, its successors and assigns forever.
