This Indenture, Made this second day of March in the year of our Lord one thousand eight hundred and ninety six between W.R. Green and Sallie A. Green - husband & wife (being of lawful age) of the County of Douglas, and State of Kansas, of the first part, and Almira J. Stoyt of Cambridge, New York of the second part.

Witnesseth, That the said parties of the first part, in consideration of the sum of Three Thousand (\$3000⁰⁰) Dollars to them in hand paid, the receipt whereof is hereby acknowledged, have sold and by these presents do grant, bargain, sell and convey to the said party of the second part her heirs and assigns forever the following tract or parcel of land situated in the county of Douglas and State of Kansas, described as follows, to-wit: All that part of the North East quarter of section No. Twenty-one (21) and of the North half of the South East quarter (1/4) of said section No. Twenty-one (21) all in Township No. Twelve (12) South of Range No. Twenty (20) East lying west of the right of way of the Leavenworth Branch of the Union Pacific railway through the East half of said section and lying south of the land deeded to L.S. Persell and recorded in Deed book 54 page 375 and excepting 12 1/80 acres in the southwest part thereof conveyed to Mattie Wagner and James B. Wagner by deed recorded in Book 58 page 95. Also the following: Beginning at a point on the North line of said South East quarter section Twenty-one (21) where said line crosses the West line of the right of way of the said Leavenworth Branch of the U.P. Railway and running west along said line 943^{1/4} ft, thence S 57° E 788^{1/2} ft. thence S 69°
