

This Indenture, Made this second day of March in the year of our Lord one thousand eight hundred and ninety two between George J. Oehle and Margurite Oehle Husband and wife of Marion Township in the County of Douglas and State of Kansas of the first part, and Flora S. Myers of the second part,

Witnesseth, That the said parties of the first part in consideration of the sum of One Thousand DOLLARS, to them duly paid, the receipt of which is hereby acknowledged, have sold and by these presents do grant, bargain, sell and mortgage to the said party of the second part all heirs and assigns forever, all that tract or parcel of land situated in the County of Douglas and State of Kansas, described as follows, to-wit: The South East quarter of Section number Twenty three (23) in Township number fourteen (14) of Range number Eighteen (18) East of the 6th P.M. 1892. This mortgage is given as part purchase price of the above described premises in connection with two other mortgages given this date by said first parties hereto. One to George E. Myers for Six Hundred dollars and one to Geo. S. Myers for seven hundred dollars, and in case of foreclosure of either of said mortgages neither of the three shall be preferred. But the money received on such foreclosure shall be divided equally between the three as their several interests may appear should said amount be less than the amount due with all the appurtenances, and all the estate, title and interest of the said parties of the first part therein. And the said

do hereby covenant and agree that at the delivery hereof they are the lawful owners of the premises above granted, and seized of a good and indefensible estate of inheritance therein free and clear of all incumbrances

This grant is intended as a Mortgage to secure the payment of the sum of One Thousand dollars according to the terms of three certain promissory notes this day executed and delivered by the said parties of the first part to the said party of the second part: of even date herewith. One for \$700 due in two years. One for \$200 due in three years and one for \$100 due four years, all drawing interest at 7% per annum payable annually.

and this conveyance shall be void if such payments be made as herein specified. But if default be made in such payment, or any part therefor, or interest thereon, or the taxes, or if the insurance is not kept up thereon, then this conveyance shall become absolute, and the whole amount shall become due and payable, and it shall be lawful for the said party of the second part or executors, administrators and assigns, at any time thereafter, to sell the premises hereby granted, or any part thereof, in the manner prescribed by law, appraisement hereby waived or not at the option of the party of the second part or executors, administrators or assigns; and out of all the moneys arising from such sales, to retain the amount then due for principal and interest, together with the costs and charges for making such sales, and the overplus, if any there be, shall be paid by the party making such sale on demand to the said parties of the first part heirs and assigns.
