

This Indenture, Made this First day of April in the year of our Lord one thousand eight hundred and ninety six between John N. Robertson and Jimmie I. Robertson Husband and Wife of Lawrence in the County of Douglas and State of Kansas of the first part, and Amelia E. Ellwell of West Brookfield Massachusetts of the second part,

Witnesseth, That the said parties of the first part in consideration of the sum of Seven Hundred DOLLARS, to them duly paid, the receipt of which is hereby acknowledged, have sold and by these presents do grant, bargain, sell and mortgage to the said party of the second part her heirs and assigns forever, all that tract or parcel of land situated in the County of Douglas and State of Kansas, described as follows, to-wit: Lot number One hundred twenty six (126) on Lawrence Street in the City of Lawrence in said County and State adjoining to the plot of said City on file in the office of the Register of Deeds of said County

with all the appurtenances, and all the estate, title and interest of the said parties of the first part therein. And the said John N. Robertson and Jimmie I. Robertson Husband and Wife do hereby covenant and agree that at the delivery hereof they are the lawful owners of the premises above granted, and seized of a good and indefeasible estate of inheritance therein free and clear of all incumbrances of every kind and nature whatsoever

This grant is intended as a Mortgage to secure the payment of the sum of Seven Hundred Dollars with interest thereon at the rate of seven per cent per annum payable semi annually according to the terms of One certain Promissory Note this day executed and delivered by the said John N. Robertson to the said party of the second part: reference to which said promissory note is hereby made for the terms thereof

and this conveyance shall be void if such payments be made as herein specified. But if default be made in such payment, or any part therefor, or interest thereon, or the taxes, or if the insurance is not kept up thereon, then this conveyance shall become absolute, and the whole amount shall become due and payable, and it shall be lawful for the said party of the second part or her executors, administrators and assigns, at any time thereafter, to sell the premises hereby granted, or any part thereof, in the manner prescribed by law, appraisement hereby waived or not at the option of the party of the second part executors, administrators or assigns; and out of all the moneys arising from such sales, to retain the amount then due for principal and interest, together with the costs and charges for making such sales, and the overplus, if any there be, shall be paid by the party making such sale on demand to the said John N. Robertson his lawful heirs and assigns.
