Witnesseth, That said parties of the first part, in consideration of the sum of

Two Hundred AND 00 DOLLARS,

the receipt of which is hereby acknowledged, do by these presents, grant, bargain, sell and convey unto said part of of the second part, his heirs and assigns, all the following described REAL ESTATE, situated in Douglas County, and State of Kansas, to-wit:

Beginning at a point fifty three and one third (53 1/3) feet west of where the center line of Hancock Street in the City of Lawrence extends east intersects the west line of section number thirty two (32); thence west two hundred and fifteen (215) feet; thence north one hundred and thirty (130); thence east two hundred and fifteen (215); thence south one hundred and thirty (130) to beginning in the south west quarter of block number four (4) in Earle's Addition to the City of Lawrence and being in Township number twelve (12) south of Range number (20) East of the Sixth Principal Meridian.

To Have and to Hold the Same, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, forever:—

Now, If said parties of the first part shall pay or cause to be paid to said part of of the second part, his heirs or assigns, said sum of money in the above described note mentioned, together with the interest thereon, according to the terms and tenor of the same, then these presents shall be wholly discharged and void; and otherwise shall remain in full force and effect. But if said sum or sums of money, or any part thereof, or any interest thereon, is not paid, when the same is due, and if the taxes and assessments of every nature which are or may be assessed and levied against said premises or any part thereof are not paid when the same are by law made due and payable, then the whole of said sum and sums, and interest thereon, shall, and by these presents become due and payable, and said part of of the second part shall be entitled to the possession of said premises.
