This Indenture, Made this 9th day of December in the year of our Lord one thousand eight hundred and ninety six between David P. Rake and Rose, his wife of Kanawha Tp in the County of Douglas and State of Kansas of the first part, and John F. Buchheim of the second part,

Witnesseth, That the said part us of the first part in consideration of the sum of Six Hundred DOLLARS, to them duly paid, the receipt of which is hereby acknowledged, have sold and by these presents do grant, bargain, sell and mortgage to the said party of the second part his heirs and assigns forever, all that tract or parcel of land situated in the County of Douglas and State of Kansas, described as follows, to-wit: Begin at the North East corner of the fractional South West quarter of Section Seven (7) Township Thirteen (13) Range Eighteen (18) Thence South Sixty (60) Rods Thence West fifty (50) Rods Thence South Sixty Eight (68) Rods Thence West thirty two Rods Seven feet more or less to a point fifty Rods East of the West line of said quarter section Thence North one hundred twenty eight (128) Rods to the North line of said quarter section Thence East on said North line to beginning with all the appurtenances, and all the estate, title and interest of the said part us of the first part therein. And the said David P. Rake do hereby covenant and agree that at the delivery hereof he is the lawful owner of the premises above granted, and seized of a good and indefeasible estate of inheritance therein free and clear of all incumbrances

This grant is intended as a Mortgage to secure the payment of the sum of Six Hundred Dollars five years after date with interest payable annually at the rate of Eight percent per annum according to the terms of One certain Promissory Note this day executed and delivered by the said David P. Rake and Rose Rake, his wife to the said party of the second part:

and this conveyance shall be void if such payments be made as herein specified. But if default be made in such payment, or any part therefor, or interest thereon, or the taxes, or if the insurance is not kept up thereon, then this conveyance shall become absolute, and the whole amount shall become due and payable, and it shall be lawful for the said party of the second part his executors, administrators and assigns, at any time thereafter, to sell the premises hereby granted, or any part thereof, in the manner prescribed by law, appraisement hereby waived or not at the option of the party of the second part his executors, administrators or assigns; and out of all the moneys arising from such sales, to retain the amount then due for principal and interest, together with the costs and charges for making such sales, and the overplus, if any there be, shall be paid by the party making such sale on demand to the said David P. Rake, his heirs and assigns.
