

This Indenture, Made this Fifth day of December in the year of our Lord one thousand eight hundred and ninety Eight between Henry Copp and Eliza Copp his wife of Eudora in the County of Douglas and State of Kansas of the first part, and Emma Kunkel of the second part,

Witnesseth, That the said parties of the first part in consideration of the sum of Eight Hundred and Thirty One and 00/100 DOLLARS, to them duly paid, the receipt of which is hereby acknowledged, have sold and by these presents do grant, bargain, sell and mortgage to the said party of the second part her heirs and assigns forever, all that tract or parcel of land situated in the County of Douglas and State of Kansas, described as follows, to-wit: Beginning North 2 1/4 West 18.21 chains of quarter Section corner on South of Section 8 Township 13 Range 21 East Thence East 8.25 feet North 560 feet East 285 feet North 560 feet West 1395 feet South 1680 feet to place of beginning containing 43 1/2 Acres, more or less. In South half of North East quarter and South half of North West quarter Section 8 Township 13 Range 21, formally being all lots in blocks 79-80-81-88-89-90-117-118-119-127-128 and 150 in the City of Eudora, according to the plat of said City and all the Streets and Alleys and Public squares adjacent thereto with all the appurtenances, and all the estate, title and interest of the said part of the first part therein. And the said Henry Copp and Eliza Copp his wife do hereby covenant and agree that at the delivery hereof they are the lawful owner of the premises above granted, and seized of a good and indefeasible estate of inheritance therein free and clear of all incumbrances Except a Mortgage of \$1500.00 given to Elmira Wilson in December 1895 due in five years from date

This grant is intended as a Mortgage to secure the payment of the sum of Eight Hundred and Thirty One and 00/100 Dollars according to the terms of One certain promissory note this day executed and delivered by the said Henry Copp and Eliza Copp to the said party of the second part: Due in five years with eight per cent. interest from date until paid interest payable annually

and this conveyance shall be void if such payments be made as herein specified. But if default be made in such payment, or any part thereof, or interest thereon, or the taxes, or if the insurance is not kept up thereon, then this conveyance shall become absolute, and the whole amount shall become due and payable, and it shall be lawful for the said party of the second part her executors, administrators and assigns, at any time thereafter, to sell the premises hereby granted, or any part thereof, in the manner prescribed by law, appraisement hereby waived or not at the option of the party of the second part her executors, administrators or assigns; and out of all the moneys arising from such sales, to retain the amount then due for principal and interest, together with the costs and charges for making such sales, and the overplus, if any there be, shall be paid by the party making such sale on demand to the said Henry Copp and Eliza Copp heirs and assigns.
