

such insurance and the amounts so paid with interest at ten per cent. per annum, shall be immediately due and payable, and shall be secured by this mortgage. Fourth. If Default, the maker or makers of said note shall fail to pay either principal or interest, when the same become due, or any note given in renewal of the note herein, or any note given as evidence of interest on any extension of the time of payment of the debt herein secured when the same shall be due; or there is failure to conform to or comply with any of the foregoing covenants or agreements, or if title of mortgagor is other than fee simple, free and unincumbered; the whole sum of money herein secured shall thereupon become due and payable at the option of the said second party without notice, and this mortgage may be foreclosed. Fifth. That the contract embodied in this mortgage shall in all respects be governed, construed and adjudged according to the laws of Kansas. Sixth. That upon the institution of proceedings to foreclose this mortgage, the plaintiff therein shall be entitled to have a receiver appointed by the court to take possession and control of the premises described herein, and collect the rents and profits thereof, the amount so collected by such receiver to be applied, under the direction of the court, to the payment of any judgment rendered or amount found due under this mortgage. Seventh. That Mortgagee's Option. any failure of the said second party to exercise any option hereby given or reserved, shall not estop it from afterwards exercising any such or other option at any time. The foregoing conditions, covenants and agreements being performed, Performance, this conveyance shall be void, and shall be released by the said second party, (and in case of failure of the said second party to release this mortgage, all claim for statutory penalty or damages is hereby released) at the cost and expense of the said first party, otherwise to remain in full Execution force and virtue.
