This indenture, made this 10th day of January in the year of our Lord, one thousand nine hundred and one between John H. Harrison and Edie Harrison his wife of Velleville in the county of Franklin and State of Kansas of the first part, and W. C. New Street of the second part, Minersville, that the said parties of the first part, in consideration of the sum of one hundred eighty five Dollars, to them duly paid, the receipt of which is hereby acknowledged, have sold, and by these presents do grant, bargain, sell and mortgage to the said party of the second part his heirs and assigns, forever, all that tract or parcel of land situated in the county of Douglas and State of Kansas, described as follows, to-wit, Twenty two and three fourths (22 ³/₄) acres commencing forty rods north of the south east corner, thence running north forty (40) rods, thence west ninety (90) rods, thence south forty (40) rods, thence east ninety (90) rods to the place of beginning. The said tract of land being in the north east quarter of Section Twenty nine (29) Township fourteen (14) N Range twenty one (21) East with the appurtenances, and all the estate, title and interest of the said parties of the first part therein. And the said parties of the first part do hereby covenant and agree that at the delivery hereof they are the lawful owners of the premises above granted, and seized of a good and indefeasible estate of inheritance therein, free and clear of all encumbrances - This grant is intended as a Mortgage to secure the payment of the sum of one hundred eighty five (\$185) Dollars, according to the terms of a certain promissory note this day executed by the said parties of the first part to the said party of the second part - And this conveyance shall be void if such payment be made as is
