MORTGAGE Standard Form, SAME DOWNSWORTH BOOK CO., LEAVENWORTH, KAN.

This Indenture, Made this Seventeenth day of June in the year of our Lord, one thousand Nineteen
 hundred and two, between Annie Sanders and Christa Sanders, her husband,
of the City of Lawrence, in the County of
Douglas, and State of Kansas, of the first part, and William F. Sinclair, of the same place,
of the second part:

Witnesseth. That the said parties of the first part, in consideration of the sum of
One Hundred **Dollars,**

to them duly paid, the receipt of which is hereby acknowledged, ha ~~ve~~ sold, and by these presents do grant, bargain, sell and mortgage to the said party of the second part his heirs and assigns, forever, all that tract or parcel of land situated in the County of Douglas, and State of Kansas, described as follows, to wit:

Lot No. Two Hundred and Thirty-four (234) on Elm Street, in the south half of Block No. Five (5), in that part of the City of Lawrence, known as North Lawrence.

The parties of the first part hereby agree that they will maintain insurance to the amount of \$100. on the buildings now or to be erected on said lot, during the existence of this mortgage, for the benefit of the party of the second part, his heirs or assigns.

with all the appurtenances, and all the estate, title and interest of the said parties of the first part therein. And the said

parties of the first part do hereby covenant and agree that at the delivery hereof they are the lawful owner(s) of the premises, above granted, and seized of a good and indefeasible estate of inheritance therein, free and clear of all incumbrances and that they will warrant and defend the same in the quiet and peaceable possession of the said party of the second part, his heirs or assigns forever, against all persons lawfully claiming the same. This Grant is intended as a Mortgage to secure the payment of the sum of One Hundred Dollars

according to the terms of One certain Mortgage Note this day executed and delivered by the said parties of the first part to the said party of the second part due in two years from date, with interest from date to maturity as evidenced by coupons attached thereto, and interest after maturity or default at the rate of ten per cent, per annum until fully paid, and this conveyance shall be void if such payments be made as herein specified. But if default be made in such payment, or any part thereof, or interest thereon, or the taxes, or if the insurance is not kept up thereon, then this conveyance shall become absolute, and the whole amount shall become due and payable, and it shall be lawful for the said party of the second part his executors, administrators and assigns, at any time thereafter to sell the premises hereby granted, or any part thereof, in the manner prescribed by law; and out of all the moneys arising from such sales to retain the amount then due for principal and interest, together with the costs and charges of making such sales; and the overplus, if any there be, shall be paid by the party of the second part, his heirs and assigns.
