Greenlee, a single man, of Douglas County, in the State of Kansas, of the first part, and The National Council of the Knights and Ladies of Security, a Corporation, of the State of Kansas, party of the second part. Witnesseth, that said party of the first part, in consideration of the sum of Twelve Hundred and one Dollar the receipt of which is hereby acknowledged, does by these presents grant, bargain, sell and convey, unto said party of the second part, and its assigns, all the following described real estate, situated in Douglas County and State of Kansas to wit: Lot number Fourteen (14) in Block number Twelve (12) in Lane's Second Addition to the City of Lawrence, according to the recorded plat thereof. To have and to hold the same, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, forever.
