 and by these presents do Grant Bargain, Sell and Convey unto the
 party of the second part, its successors and legal representatives,
 the following described real estate situated in the County of Douglas

 One Hundred and Fifty Three (153) and the North Half of One
 Hundred and Fifty Two (152) all in Block Fifty six (56) in West

 with all and singular the tenements, hereditaments and appur-
 tenances thereto belonging. The party of the first part covenants and
 agrees that at the delivery hereof they are the lawful owners of
