Jacobs and Clara, his wife, have this day executed and delivered their certain promissory note, in writing to said party of the second part, of which the following is a copy: Lawrence, Kansas, December 26th, 1903. \$1,050.00. On or before Five (5) years from date, for value received, we promise to pay to the order of Henry Bailey Ten hundred and Fifty (\$1050.00) Dollars, at the Working National Bank, in Lawrence, Kansas, with interest thereon at the rate of Six (6) per cent per annum, said interest to be paid semi-annually. The right to pay the principal sum or any part thereof of this mortgage is hereby given parties of the first part same to be paid at any interest paying time. Now, if said parties of the first part shall pay or cause to be paid to said party of the second part, his heirs or assigns, said sum of money in the above described note, mentioned, together with the interest thereon, according to the terms and tenor of the same, then these presents shall be wholly discharged and void, and otherwise shall remain in full force and effect. But if said sum or sum of money, or any part thereof, or any interest thereon, is not paid when the same is due, and if the taxes and assessments of every nature which are or may be assessed and levied against said premises, or any part thereof, are not paid when the same are by law made due and payable, then the whole of said sums, and interest thereon, shall and by
