This Indenture Made this 20th day of September in the year of our Lord one thousand eight hundred and eighty two between David T. Clinger and Sallie A. Clinger his wife of Willow Springs in the County of Douglas and State of Kansas of the first part and Parmelia Horner of the second part:

Witnesseth That the said parties of the first part in consideration of the sum of One hundred and fifty Dollars to them duly paid the receipt of which is hereby acknowledged have sold and by their parents do grant bargain sell and mortgage to the said party of the second part his heirs and assigns forever all that tract or parcel of land situated in the County of Douglas and State of Kansas described as follows to wit: The South East Quarter of the North East quarter of Section Twenty nine (29) Township Fourteen (14) Range Thirteenth (13) with the appurtenances and all the estate title and interest of the said parties of the first part therein. And the said David T. Clinger does hereby covenant and agree that at the delivery hereof he is the lawful owner of the premises above granted and seized of a good and indefeasible estate of inheritance therein and will warrant and defend the same and that the same is free and clear of all incumbrances.

This Grant is intended as a Mortgage. To secure the payment of the sum of One hundred and fifty dollars and interest thereon according to the terms of one certain note this day executed and delivered by the said David T. Clinger to the said party of the second part: and this conveyance shall be void if such payment be made as herein specified. But if default be made in such payment or any part thereof or interest thereon or the taxes then this conveyance shall become absolute and the whole shall become due and payable and it shall be lawful for said party of the second part her executor administrators and assigns at any time thereafter to sell the
