COUPON MORTGAGE—SINGLE DOWNSIDE BOOK CO., LEAVENWORTH, KAN., NO. 1244

This Indenture, Made this 22nd day of October in the year of our Lord one thousand nine hundred and one between Martha J. Morrison

of Lawrence in the County of Douglas and State of Kansas, of the first part, and Mrs. C. B. Miller, Lawrence Kansas

of the second part:

Witnesseth, That the said part 1st of the first part, in consideration of the sum of Four hundred DOLLARS,

to her duly paid, the receipt of which is hereby acknowledged, has sold and by these presents do grant, bargain, sell and mortgage to the said part 1st of the second part, her heirs and assigns forever, all that tract or parcel of land situated in the County of Douglas and State of Kansas, described as follows, to wit:

Lot #86 NW Hampshire St. Lawrence Kansas

with the appurtenances and all the estate, title and interest of the said part 1st of the first part therein. And the said Martha J. Morrison

do hereby covenant and agree that at the delivery hereof she is the lawful owner of the premises above granted and seized of a good and indefeasible estate of inheritance therein, free and clear of all incumbrances, and that she will warrant and defend the same against all claims whatsoever.

This Grant is intended as a MORTGAGE to secure the payment of the sum of Four hundred Dollars, according to the terms of her certain promissory note, this day executed by the said Martha J. Morrison

note being given for the sum of Four hundred Dollars, dated Oct 22nd 1901 due and payable in Five year from date hereof, with interest thereon from the date thereof until paid, according to the terms of said note and coupons thereto attached. And this conveyance shall be void if such payment be made as in said note and coupons thereto attached, and as is hereinafter specified. And the said part 1st of the first part hereby agree to pay all taxes assessed on said premises before any penalties or costs shall accrue on account thereof, and to keep the said premises insured in favor of the said mortgagee, in the sum of Four hundred DOLLARS,

in some insurance company satisfactory to said mortgagee, in default whereof the said mortgagee may pay the taxes and and accruing penalties, interests and costs, and insure the same at the expense of the part 1st of the first part, and the expense of such taxes and accruing penalties, interests and costs and insurance, shall from the payment thereof, be and become an additional lien under this mortgage upon the above described premises, and shall bear interest at the rate of 10 per cent. per annum. But if default be made in such payment, or any part thereof, or interest thereon, or the taxes assessed on said premises, or if the insurance is not kept up thereon, then this conveyance shall become absolute, and the whole principal of said note, and interest thereon, and all taxes and accruing penalties and interest and costs thereon remaining unpaid or which may have been paid by the part 1st of the second part, and all sums paid by the part 1st of the second part for insurance, shall be due and payable or not at the option of the part 1st of the second part; and it shall be lawful for the part 1st of the second part her executors, administrators and assigns, at any time thereafter, to sell the premises hereby granted, or any part thereof, in the manner prescribed by law, appraisement hereby waived or not at the option of the part 1st of the second part her executors, administrators or assigns; and out of all the moneys arising from such sale to retain the amount then due or to become due according to the conditions of this instrument, together with the costs and charges of making such sale, and the surplus, if any there be, shall be paid by the part 1st making such sale on demand, to the said Martha J. Morrison her heirs and assigns.
