This Indenture, Made this 28<sup>th</sup> day of February in the year of our Lord, 1917, between Priscilla J. Wilson his wife of Douglas in the County of Douglas and State of Kansas, of the first part, and William Henry of the second part:

Witnesseth, That the said part 1<sup>st</sup> of the first part, in consideration of the sum of Two Thousand (\$2000<sup>00</sup>) Dollars, to them duly paid, the receipt of which is hereby acknowledged, had Gold, and by these presents do grant, bargain, sell and mortgage to the said part 4<sup>th</sup> of the second part his heirs and assigns, forever, all that tract or parcel of land situated in the County of Douglas, and State of Kansas, described as follows, to wit:

West one half 1/2 South west quarter 4 Sec no. Twenty five (25) Town 12 Range (17) containing 80 acres more or less

with all the appurtenances, and all the estate, title and interest of the said part 1<sup>st</sup> of the first part therein. And the said Alvey E. Wilson & Priscilla J. Wilson his wife do hereby covenant and agree that at the delivery hereof being the lawful owner of the premises, above granted, and seized of a good and indefeasible estate of inheritance therein, free and clear of all incumbrances

This Grant is intended as a Mortgage to secure the payment of the sum of Two Thousand Dollars according to the terms of One certain Note this day executed parties of the first part to the said part 4<sup>th</sup> of the second part due five years after date with interest at six per cent per annum payable annually with privilege of paying one hundred dollars or more at any interest paying period.

and this conveyance shall be void if such payments be made as herein specified. But if default be made in such payment, or any part thereof, or interest thereon, or the taxes, or if the insurance is not kept up thereon, then this conveyance shall become absolute, and the whole amount shall become due and payable, and it shall be lawful for the said part 4<sup>th</sup> of the second part his executors, administrators and assigns, at any time thereafter to sell the premises hereby granted, or any part thereof, in the manner prescribed by law; and out of all the moneys arising from such sales to retain the amount then due for principal and interest, together with the cost and charges of making such sales, and the overplus, if any there be, shall be paid by the part 4<sup>th</sup> making such sale, on demand, to said parties of the first part heirs and assigns.
