This Indenture, Made this 15th day of December, in the year of our Lord, nine thousand nine hundred and seven, between Amos Ralph Weybright and Emma E. Weybright his wife, of Marion, K.T., in the County of Douglas, and State of Kansas, of the first part, and
J. A. Kessler - Cashier of the second part:

Witnesseth, That the said party of the first part, in consideration of the sum of Eight Hundred \$ 700 Dollars,

(other) duly paid, the receipt of which is hereby acknowledged, have sold, and by these presents do grant, bargain, sell and mortgage to the said party of the second part his heirs and assigns, forever, all that tract or parcel of land situated in the County of Douglas,

and State of Kansas, described as follows, to wit: A tract of the North half of the North East quarter
(4) of Section fifteen (15) in Township fourteen (14) of Range Eighteen (18)
described as follows: Commencing at a point on the West line of said quarter section thirty-five (35) rods
South of the middle West corner and quarter section line; thence one hundred forty (140) rods
parallel, with north line of said quarter section to the East line thereof; thence with
said East line five (5) rods to the N.E. Cor. of a ten acre tract in a new
line of the South East Cor. of said quarter Sec.; thence West forty (40) rods to the
North West corner of said tract; thence South to the South west corner of said tract;
thence West one hundred twenty (120) rods along center line of said quarter section to the
west line of said quarter section; thence north along said west line to place
of beginning; comprising Thirty-five (35) acres.

with all the appurtenances, and all the estate, title and interest of the said part of the first part therein. And the said Amos Ralph

E. Weybright do hereby covenant and agree that they are the lawful owner of the premises, above granted, and seized of a good and indefeasible

estate of inheritance therein, free and clear of all incumbrances

This Grant is intended as a Mortgage to secure the payment of the sum of

according to the terms of one certain provisional note this day executed.

Amos Ralph and Emma E. Weybright to the said party of the second part

bearing equal date hereunto due in 5 years with interest at 6% for annum payable annually!

and this conveyance shall be void if such payments be made as herein specified. But if default be made in such payment, or any part thereof, or interest thereon, or the taxes, or if the insurance is not kept up thereon, then this conveyance shall become absolute, and the whole amount then becoming due and payable, and it shall be lawful for the said party of the second part, executors, administrators and assigns, at any time thereafter to sell the premises hereby granted, or any part thereof, in the manner prescribed by law; and out of all the moneys arising from such sale to retain the amount then due for principal and interest, together with the cost and charges of making such sales, and the overplus, if any there be, shall be paid by the party making such sale, on demand, to said Amos Ralph and Emma E. Weybright heirs and assigns.
