NOW, If said part 23rd of the first part shall pay or cause to be paid to said part 1 of the second part, its successors, said sum of money in the above described note mentioned, together with the interest thereon, according to the terms and tenor of the same, then these presents shall be wholly discharged and void, and otherwise shall remain in full force and effect.
