This Indenture, Made this 11 day of April A.D. 1909, between Susanna Long unmarried of Douglas County in the State of Kansas, of the first part, and The Lawrence Building And Loan Association, of Lawrence, Kansas, of the second part.

Witnesseth, That the said party of the first part, in consideration of the sum of One Thousand Dollars, the receipt of which is hereby acknowledged, do by these presents grant, bargain, sell and convey, unto said party of the second part, its successors and assigns, all of the XXX following described real estate, situated in the County of Douglas, and State of Kansas to-wit; Lot No. Twelve (12) Block No. (26) twenty-six Sinclairs Addition to the City of Lawrence. To have and to hold the same Together all and singular, the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining forever.

Provided Always, And this instrument is executed and delivered to secure the payment of the sum of One Thousand Dollars, (1000.00) with interest and premium thereon and such fines and charges as may become due to said party of the second part under the terms and conditions of the contract note secured hereby, advanced by the said The Lawrence Building And loan Association to the party of the first part upon 10 shares of class G of the Capitol stock of said Association, evidenced by Certificate No. 3 which said shares have been assigned to the said Association, with all future payments, earnings and dividends thereon, which said interest premium and dues on said shares, the first party agrees to pay in monthly installments, making a total monthly payment of (\$12.70) payable as follows. April 1- 10-1909 Dollars (\$ ) on or before the last day of \_\_\_\_ 190 \_\_\_\_ and a like sum on or before the last day of each and every month thereafter to and including the month of April 1919. Now if XXX said party of the first part shall pay or cause to be paid to the party of the second part the amount due it under said contract note, in accordance with the terms thereof, and comply with all the provisions and agreements in said note contained, then these presents shall be void; otherwise in full force and effect, and may be foreclosed as in said contract note provided.
