Witnesseth, that the said party of the first part, in consideration of the sum of Two Thousand Eight Hundred and no/100 Dollars in hand paid, the receipt whereof is hereby acknowledged, do hereby grant, bargain, sell, convey, and confirm to the said party of the second part, its successors and assigns; the following described real estate in the County of Douglas and State of Kansas, to-wit: The North One Half $(\frac{1}{2})$ of the South West Quarter $(\frac{1}{2})$ of Section Eight (8) Township Thirtean (13) Range Twenty (20) in Douglas County, Kansas, To Have And To Hold the same, with the appurtenances thereto belonging or in anywise appertaining, including any right of homestead and every contingent right or estate therein, unto the said party of the second part, its successors and assigns fr forever; the intention being to convey an absolute title in fee to said premises. And the said Orrin L.Miller and Isabel Miller, his wife, hereby covenant that they are lawfully seized of said premises and have good right to convey the same; that said premises are free and clear of all incumbrances; and that they will warrant and defend the same against the lawful claims of all persons whomsoever. Provided However, that if the said party of the first part shall pay or cause to be paid, to the said party of the second part, its successors and assigns, the principal sum of \$2800.00 in patments as follows: One note of even date, herewith due in Five (5) years with privilege granted parties of the first part of paying \$100.00 or any multiple thereof at any interest paying period after one year. with interest at the rate of six per cent per annum, payable on the 17th day of September and March in each year, together with interest at the rate of ten per cent per annum on any installment of interest which shall not have been paid when due, and on said principal sum after the same becomes due or payable, according to the tenor and MXXM effect of a promissory note, bearing even date herewith, executed by the said Orrin-L.
