This Indenture Made this 1 day of March A. D. 1909 between Edgar Klein
 and Blanche H. Klein, his wife, of Douglas County in the State of Kansas,
 of the first part, and The Lawrence Building And Loan Association of
 Lawrence Kansas, of the second part. Witnesseth, That the said parties
 of the first part in consideration of the sum of Two Thousand Dollars, the
 receipt of which is hereby acknowledged, do by these presents grant,
 bargain, sell and convey, unto the said party of the second part, its
 successors and assigns, all the following described real estate situated
 in the County of Douglas and State of Kansas to-wit: Lot No. Two (2),
 in Block No. Twenty one (21) in Sinclairs Addition to the City of
 Lawrence To Have and To Hold The Same, Together with all and singular,
 the tenements, hereditaments, and appurtenances thereunto belonging, or
 in any wise appertaining, forever. Provided Always, and this Instrument
 is executed and delivered to secure the payment of the sum of Two Thousand
 Dollars, with interest and premium thereon, and such fines and charges
 as may become due to said party of the second part under the terms and
 conditions of the contract note secured hereby, advanced by the said
 The Lawrence Building And Loan Association to the parties of the first part
 thereon Twenty shares of class G, of the Capital of said Association
 , evidenced by certificate No. 3, which said shares have been assigned
 to said Association with all future payments, earnings and dividends
 thereof, which said interest premium and dues of said shares the first
 part agree to pay in monthly installments making a total monthly
 payment of \$ 29.20, payable as follows: Twenty Nine 20/100 Dollars,
 (\$29.20) on or before the last day of March 1909 and a like sum on or
 before the last day of each and every month thereafter to and including
 the month of February 1917. Now if said parties of the first part shall
 cause to be paid to the party of the second part the amount due it
 under said contract note, in accordance with the terms thereof, and comply
 with all the provisions and agreements in said note contained, then these
 presents shall be void; otherwise in full force and effect, and may be
 foreclosed as in said contract note provided. In Witness Whereof the said
