

This Indenture Made and dated this Second day of May in the year of our Lord one thousand nine hundred and eleven, between the Kansas Natural Gas Company, a corporation organized and existing under the laws of the state of Delaware, herein after called the "Gas Company", party of the first part, and the fidelity Title and Trust Company, a corporation created and existing under the laws of the state of Pennsylvania, whose principal office or place of business is at Pittsburgh, Pennsylvania, hereinafter called the "Trustee" party of the second part:

Whereas, the Gas Company did heretofore authorize the issue of its First Mortgage Twelve Year Six Per Cent. Sinking Fund Gold Bonds to the amount of four Million Dollars, which bonds in words and figures read as follows:

The Kansas Natural Gas Company, a corporation created and existing under the laws of the state of Delaware, for value received, promise to pay to the bearer at the office of the Fidelity Title and Trust company, in the City of Pittsburgh the sum of One thousand Dollars (\$1,000.00) in gold coin of the United States of America, of or equal to the present standard of weight and fineness, of the ~~XIX~~ first day of May, 1916, and to pay interest thereon semi-annually, at the rate of six per centum (6 per cent) per annum, from the first day of May, 1904, payable in like gold coin at the office of the Fidelity Title and Trust company in the city of Pittsburgh, on the first days of November and May, in each year, until the principal shall have been fully paid, and on presentation and surrender of the coupons hereto annexed, as the same become due, respectively. All payments upon said bonds, both of principal and interest, shall be made without deduction of any United States, State, County, or Municipal tax or taxes, which said Kansas Natural Gas Company, its successors or assigns, may be required to pay thereon or retain therefrom, under or by reason of any present or future law, the said Kansas Natural Gas Company hereby assuming, and agreeing to pay such tax or taxes. This Bond is one of the series of Four Thousand (4,000) bonds of like tenure, amount and date, numbered consecutively from one (1) to four Thousand and (4,000), both numbers inclusive, the payment of the principal and interest whereof is equally and ratably secured by a mortgage or deed of trust, duly executed by the Kansas Natural Gas Company to the Fidelity Title and Trust Company of the city of Pittsburgh, Trustee, bearing even date herewith, and duly recorded in the office for the recording of deeds in the city of Wilmington, Delaware, and in the office of the Recorder of Deeds in and for the County of Allegheny, in the City of Pittsburgh, Pennsylvania, and in the Recorders' offices in the Counties of Montgomery, Allen, Wilson, Elk, Labette, Neosho, Chautauqua, Anderson, Woodson and Coffey, in the state of Kansas, and covering all of the gas wells, oil wells, leases, franchises, rights, privileges and other property of the said Kansas Natural Gas Company, mentioned and described in the
