has been made upon it that it should execute properly written instruments or deeds of assignment, conveying the same to the Trustee as additional security for the said bonds and subject to all the terms and conditions of the said mortgage, and the Gas Company desires to comply with such demand; Now, Therefore, This Indenture Witnesseth, That in order to comply with the said demand and keep its covenants under the said mortgage and to secure the payment of the said issue of bonds now remaining unpaid and in consideration of the premises and of the sum of one dollar to it well and truly paid by the Trustee at or before the ensealing and delivery hereof, the receipt whereof is hereby acknowledged, the Gas Company has granted, bargained, sold, aliened, enfeoffed, released, remised, conveyed, confirmed, assigned, transferred, set over, pledged and mortgaged, and by these presents does grant, bargain, sell, alien, enfeoff, release, remise, convey, confirm, assign, transfer, set over, pledge and mortgage unto the Trustee, the party of the second part, its successors and assigns in the trust by the said mortgage created, all of the following described property: First. All that certain gas transportation plant consisting of a system of pipe lines which commence in Montgomery County, Kansas near the OklahOma state line and run north and northeasterly to Kansas City, and St. Joseph, Missouri, Kansas City, Atchison Leavenworth, Lawrence and Topeka, Kansas, and easterly to Carthage, Joplin, Webb City, and other points in Southwestern Missouri, and Pittsburg, Galena, Oswego and other towns in Southeastern Kansas. Together with all drips, valve reducers, meters, pumping or compressor stations and engines, appliances, fittings, equipment, fixtures, structures, machinery and property belonging to or connected with the said pipe line plant or system, and all extentions, feeders, branch lines and gathering lines connected therewith. That portion of the said pipe line system which lies in Douglas County, Kansas, consisting of;-(a) Sixteen inch trunk line which runs from a point in the county line between Dougles and franklin counties, near the southwest corner of the South east quarter of section eighteen, township fifteen, range twenty, and thence northerly across sections eighteen, seven and six in township fifteen, range twenty; and sections thirty-one, thirty, nineteen, eighteen, seven and six in township fourteen, range twenty; and sections thirty. one, thirty, nineteen, eighteen, seventeen, eight, four and five in township thirteen, range twenty; and sections thirty-two, thirty-three, twenty-eight, twenty-one and sixteen in township twelve, range twenty to a point near the southeast corner of the southeast quarter of the last mentioned section in the county line between Douglas and Leavenworth counties. (b) Twelve inch branch line which connects with and runs from the above described sixteen inch trunk line at a point in the southwest quarter of the southeast quarter of section eighteen, township thirteen, range twenty, and thence northwesterly across said section eighteen, and sections thirteen, fourteen, fifteen, sixteen, nine, eight and
